### **NB. Other Affiliations**

(i) **SLSA**

LSV is recognised as the Victorian State Centre of SLSA and subsequently as part of affiliation with LSV, the Life Saving Club committee should note that the Life Saving Club will automatically be affiliated with Surf Life Saving Australia. As such the Life Saving Club is required to abide by and be subject to the Constitution, By-Laws, Regulations and Resolutions, together with the awards and equipment of SLSA, without reservation. This affiliation allows the Life Saving Club to access SLSA programs, competitions, sponsorships and grants.

(ii) **SLSV**

Life Saving Clubs previously affiliated with SLSV as at 30 June 2005 will continue to be recognised as affiliated with SLSV in accordance with the resolutions of SLSV at general meetings of that organisation.

(iii) **RLSSAV**

A Life Saving Club affiliated with RLSSAV as at 30 June 2005 will be deemed to have re-affiliated with RLSSAV if the Life Saving Club maintains its affiliation with LSV.
