

Agreement

As an athlete / Team Management, I understand that representing Victoria is a privilege. As a representative for Lifesaving Victoria I agree to abide by the following terms and conditions in relation to involvement (directly and indirectly) Lifesaving Victorian State Team, Surf Life Saving Australia (SLSA), Royal Life Saving Society of Australia (RLSSA) competitions and activities. I also understand and agree that this agreement must be signed by me before any departure from the state and that this code of conduct shall apply for the duration of the competition or tour including all related travel arrangements.

Obligations

I undertake and agree:

- To be a financial member of and approved Lifesaving Club and to be responsible for all costs allocated to me associated with my Involvement in a team representing Lifesaving Victoria
- To conduct myself in an appropriate manner so as not to bring myself, my team, or Life Saving Victoria into disrepute.
- Be currently proficient in my award as required by SLSA
- To understand that inappropriate behavior whenever representing Lifesaving Victoria and whilst at official events or when wearing official uniform will not be tolerated.
- Team members are to be treated with respect. There will be consequences for unacceptable behavior including but not limited to exclusion, bullying and harassment towards other members of the team.
- That harassment (including verbal, physical, racial and sexual) of coaches, officials, chaperones, other team members, volunteers and spectators will not be tolerated. and that appropriate action will be taken by the team management if it does.
- It is expected that team members will act as a role model for Lifesaving Victoria.
- To adhere to reasonable control, management and directions given by my team management.
- To be able to attend training sessions as set out by the team management.
- To respect the officials' decisions and comply with the rules of competition.
- To ensure all facilities and equipment are to be used for their proper purposes and should be used with care.
- All competitors to wear Personal Equipment Protection as outlined by SLSA and under the instruction from team management for training and competition.
- To comply with the notion of "sportsmanship" and respecting your opponent's ability is expected from all team members during competition.

- To understand consumption of alcohol by team members is prohibited outside formal and sanctioned functions. Alcohol shall not be consumed to excess.
- To disclose forthwith to team management any illness/injury that may prejudice my proper participation in the competition.
- To withdraw from the team forthwith if so directed by team management, if in his/her opinion and after consultation with medical officer/s, I am unable to perform in the competition to the best of my ability due to illness/injury.
- I undertake and agree to attend and participate in, to the best of my ability, all training sessions, testing and Team meetings.
- I acknowledge that my membership of the team is conditional upon my being eligible to compete under the rules and regulations of my club, LSV, SLSA, RLSSA and, I declare that I am so eligible.
- I agree to accept personal liability including full financial responsibility for any damages or losses caused through my actions which constitute a breach of the conditions detailed in this document.
